**Target Audience:** This course is intended for clinicians at the intermediate to advanced levels.

**Prerequisites:** This class is open to matriculated students in psychoanalysis track who have patients in analytic treatment.

**Format:** This class will involve case presentation by a participant with small group discussion to follow the presentation.

**Description:** The course seeks to examine closely the fine-tuned analytic process of one psychoanalytic case. We will explore verbatim notes along transference, countertransference, clarification, interpretation, resistance, linking, dreams, and frame. In this seminar participants present adult case material. A variety of technical issues related to working with adults in psychoanalysis are discussed.

**Michael Macklin, MD**, is a practicing psychoanalyst in Chapel Hill. He has a particular interest in the widening scope of practice of psychotherapy and psychoanalysis, as well as in the broadest theoretical perspectives in psychoanalytic theory. He graduated from the UNC-Duke Psychoanalytic Education Program, now a component of the Psychoanalytic Center of the Carolinas (PCC). He taught many classes in the UNC-Duke Psychoanalytic Education Program, including Object Relations Theory, Self-Psychology, and Widening Scope. He was co-chair for many years of the theory section of the psychoanalytic curriculum committee. He is a member of the faculty of the PCC, as well as a supervising and personal training analyst.

### **Course Learning Objectives**

Class participants will be able to:

1. Describe how to look for indicators that a patient may be ready to move from psychoanalytic psychotherapy into psychoanalysis and how to approach the patient about making this change.
2. Describe how to recognize and intervene with resistance to free association.
3. Discuss how to understand and interpret the meanings of fantasies and dreams.
4. Discuss methods to help the analysand reveal or elaborate on the transference.
5. Discuss ways of interpreting the meanings of transference.
6. Describe methods for recognizing and using countertransference issues.
7. Describe the consideration of the quality of one's interpretations as being experience-near, having continuity, and timeliness.
8. Discuss the helpfulness of one's interventions as observed by changes in the patient's productivity, affective interactions, or ability for self-analysis.
9. Identify and work with the influence of culture, race, gender in the course of treatment.
