Target Audience: This course is intended for clinicians at the intermediate to advanced levels.

Prerequisites: This class is open to matriculated students in psychoanalysis track who have patients in analytic treatment. Students should have completed most of the core curriculum.

Format: This class will involve case presentation by one or two participants, with small group discussion to follow the presentation. Some participants will likely also have a chance to present their work for one session. There will be an out of class assignment to discuss a case with a peer and to write a reflection on the case presented.

Course Description: The course seeks to examine closely the fine-tuned analytic process of one psychoanalytic case. We will explore verbatim notes with attention to transference, countertransference, clarification, interpretation, resistance, linking, dreams, and frame. In this seminar participants present adult case material. A variety of technical issues related to working with adults in psychoanalysis are discussed.

1. Describe how to look for indicators that a patient may both benefit from and be in need of a psychoanalysis.
2. Describe how to approach a patient about deepening their treatment.
3. In an individual case, describe obstacles to engagement related to similarities and differences in culture, race, and gender identification.
4. Develop and demonstrate an associative process as a peer listening to a peer's process.
5. Describe the transference of the case presented and how to help the analysis and to elaborate the transference further.
6. Describe methods for recognizing and using countertransference issues.
7. Describe the consideration of the quality of one's interpretations as being experience-near, having continuity, and timeliness.
8. Describe more than one choice for the analyst's/ therapist's intervention and explore the meanings of each
